Transcurrido dicho plazo sin que se haya hecho uso de este derecho, las resoluciones serán firmes y las multas podrán ser abonadas en período voluntario dentro de los quince días siguientes a la firmeza, con la advertencia de que, de no hacerlo, se procederá a su exacción por vía ejecutiva, incrementado con el recargo del 20% de su importe por apremio.
